Declaration on suitability of the use of NCÅ-Verodan products in Halal and Kosher food production lines

The Kosher and Halal rules prohibit the consumption of ethanol. **NCÅ-Verodan A/S** is not officially certified to produce Kosher or Halal products, as this is a certification intended for food production facilities. However, many of our customers are certified as such and request declarations about the suitability of our products for use in their Halal or Kosher certified facilities. Herewith general information about the suitability of our products for use in Halal and Kosher certified facilities is presented.

Materials of animal origin

Our raw materials of our products are from a synthetic or vegetable origin and do not contain any raw materials of animal origin. Also, during production there is no contamination with materials from animal origin. We are in contact with our suppliers to control no raw materials of animal origin are used.

Alcohols

The consumption of ethanol is forbidden for followers of the Islamic faith. Any ethanol ranging between 1 and 15% is considered to be Haram (non-Halal, forbidden), whereas ethanol less than 1% is considered as preserving agent and its Halal status is allowed. Any ethanolic solution higher than 15% could be used in industries, but is toxic for human consumption. Some of the products do contain alcohol. The alcohols that we use in our products are ethanol and isopropanol. There is no concern about consuming any residues from alcohols on treated surfaces in the food industry because:

- 1) All these alcohols have a high vapour pressure and evaporate completely within minutes after application on the surface so before any food comes into contact with the treated surface.
- 2) Ethanol used in our products is always denatured with isopropanol and not suitable for human consumption. Isopropanol is chemically different from ethanol and could never be considered as "haram" because they are not intoxicating alcohols. There is no concern for toxicity of these products when used on food contact surfaces, because there are no residues as indicated above. Furthermore, during the long-term marketing of these alcohol-based products there have not been any adverse events reported to us from their use in Halal, Kosher or other food processing lines, further supporting the fact that there are no residues of these products and there is no concern for human health even when the surfaces are not rinsed off after application.
